Following the recommendation of the Federal Government, we have decided to suspend all in-person gatherings until April 30, 2020. This means for the month of April:

- Worship services will not be in-person gatherings. We continue to work on live-streaming options for both campuses and will be promoting these options on our Facebook page, and our YouTube channel.
- All church-sanctioned activities will be postponed. There will be no meetings such as
 youth groups, Bible studies, or linking-arms. If you are meeting in a small group of any
 sort, we cannot decide for you but strongly encourage you to use a virtual platform such
 as Zoom meeting or Google Hangouts and to be respectful of the need for social
 distancing.
- Neither of our buildings will be open for regular use. This is to encourage us all to honor

- Building reservations will be cancelled or postponed and neither campus will be available for rent during the month of April.

- Our pastors and elders continue to care for the flock as well as they can. Granted, it will
